

## TOWN OF CARY RATES

**PROPERTY TAX RATE:** (per \$100 of assessed value annually) \$0.33

**SOLID WASTE FEE:** (monthly charge) \$14.00

The Town of Morrisville water and sewer system was officially merged with the Town of Cary system effective April 1, 2006. As part of the merger agreement, merger related costs will be recovered through the rate differentials shown below until such time as the costs are fully recovered.
